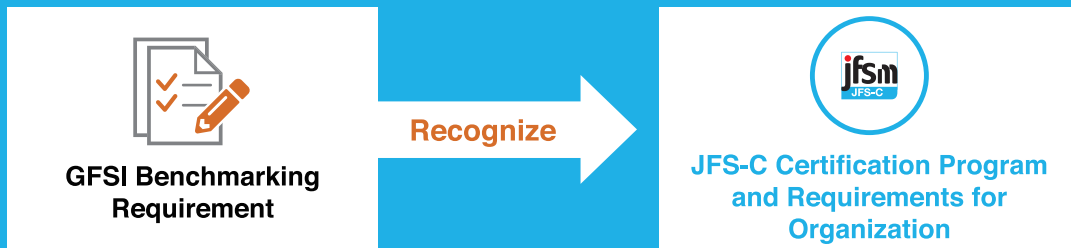
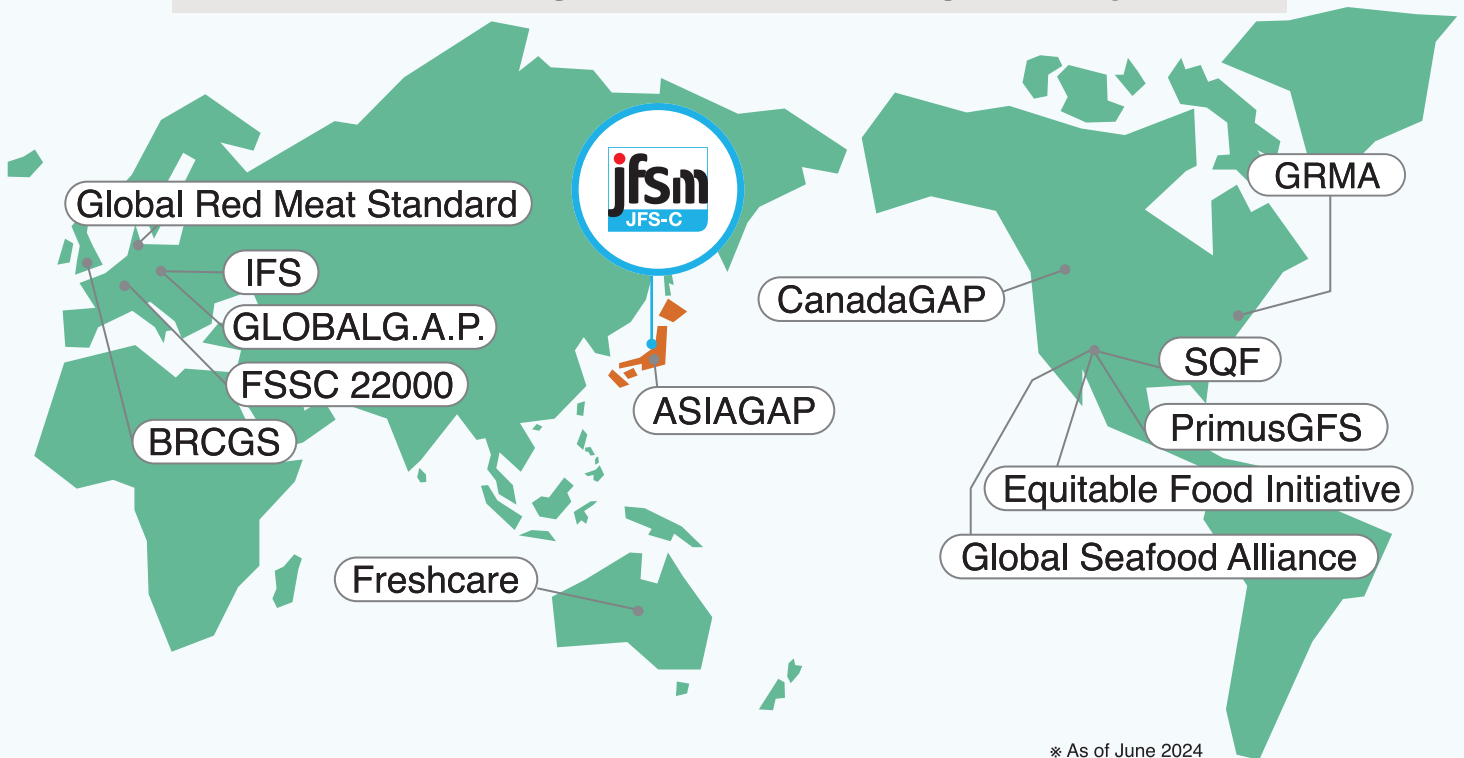

**The Global Food Safety Initiative (GFSI)** is a coalition launched by the Consumer Goods Forum (CGF), a global alliance of retailers, manufacturers, service providers, and other stakeholders across 70 countries. GFSI's work in benchmarking and harmonisation fosters mutual acceptance of GFSI-recognised certification programmes across the industry and enables a simplified "once certified, recognised everywhere" approach. They are easy for a wide range of food business operators, regardless of business size, to work on and improve their food safety level step by step.

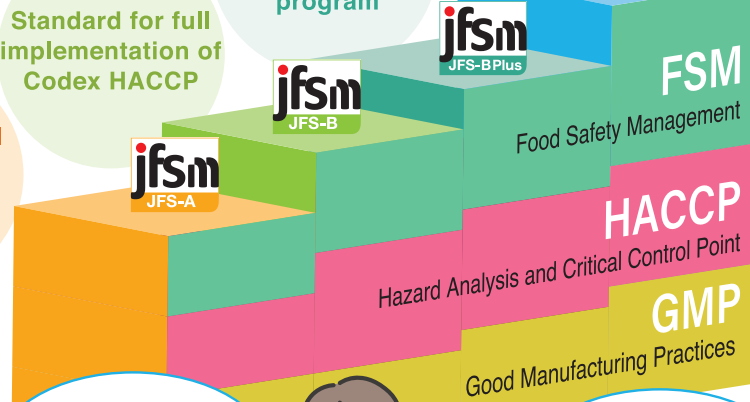
